## 4. APPROVAL OF AGENDA

## 5. PRESENTATIONS

A. Mr. Joseph O’Hern, Community Health Advocate-Columbia County QuitDoc Foundation  
- Tobacco Retail Licensing

Mr. O’hern presented members with an information packet and stated he oversees the Tobacco Free Program. He addressed the lack of enforcement with youth being able to purchase tobacco products and recommended a local Tobacco Retail License Policy.

Mr. Green inquired what communities currently have this type of policy. Mr. O’hern stated Alachua County has adopted a local Tobacco Retail License Policy.

Mayor Witt stated the Chamber of Commerce is a separate entity and not run by the City of Lake City.

Mayor Witt stated that all requests for funding are addressed annually during the budget process and is open to anyone who would like to request funding from the City.

Mr. Warren stated he and two other citizens felt threatened by a Public Works employee during a peaceful protest at Sallie Mae Jerry Park and expressed concerns with the City's handling of his complaint regarding this incident.

Mr. Helfenberger stated he is following City Policy with the handling of the complaint. He reported the investigation into the complaint is being handled by the Lake City Police Department and he will wait to make any recommendations until after he reviews the findings of the investigation.

- C. Glenel Bowden, 1156 NE Bascom Norris Drive, Lake City, FL, addressed Council regarding the need for employee training on how to handle situations where the public is involved. He asked for an explanation as to the obligations of the City regarding the Blanche.
