## Lake City Man Arrested in Child Exploitation Case

On Sunday, August 24, 2025, the Lake City Police Department received a CyberTip from the National Center for Missing and Exploited Children (NCMEC) regarding suspected child sexual exploitation material being shared through the social media platform Snapchat.

Upon review of the CyberTip, detectives confirmed that an image sent via Snapchat depicted a prepubescent child engaged in sexually explicit conduct. Detectives determined that the reported account was registered to a Lake City man.

Detectives identified the suspect as Jordan Hoffman, 33, of Lake City. Through investigative steps, including account verification by phone number, email address, and IP address logs, detectives confirmed Hoffman was responsible for the Snapchat account that shared the explicit material. Further investigation revealed Hoffman was also the subject of a second CyberTip for sending additional images of a child unclothed.

Hoffman was arrested and transported to the Columbia County Detention Center.

“Protecting our children from online predators remains one of our highest priorities,” stated Chief of Police Gerald Butler. “We will continue to pursue those who use technology to exploit children and hold them accountable.”
