Three arrested following series of armed home invasion robberies

Between August 19 and August 31, 2025, officers from the Lake City Police Department responded to two separate home invasion robberies within the city, and the Columbia County Sheriff's Office responded to a third in unincorporated Lake City.

On Tuesday, August 19, 2025, at approximately 1:59 A.M., officers were dispatched to 1283 SW Zesty Circle, Apartment 102, regarding an armed robbery. Victims stated that two masked black males wearing black clothing and gloves forced entry into the apartment after yelling "Sheriff's Office." Both suspects were armed with handguns and demanded money from the occupants, stealing cash and an iPhone 14 before fleeing.

On Thursday, August 28, 2025, at approximately 12:01 A.M., officers responded to 3853 NW Huntsboro Street, Apartment 101, in reference to another armed home invasion. Victims reported that three black males, all wearing masks, gloves, and black clothing, forced entry after shouting "Columbia County Sheriff's Office." The suspects held the victims at gunpoint and stole cash and an iPhone 14 before fleeing the area.

On Sunday, August 31, 2025, at approximately 9:54 P.M., deputies from the Columbia County Sheriff's Office responded to 134 SW Petunia Place in unincorporated Lake City in reference to a home invasion robbery. The victim stated that four black male suspects—two wearing all black, one in camouflage, and one in a gray hoodie—entered the residence armed with handguns with extended magazines. The suspects demanded to know where money was located and ransacked the home before fleeing on foot. Jewelry, watches, cologne, and clothing were stolen.

Detectives have noted similarities among the incidents, including suspects impersonating law enforcement, use of dark clothing and masks, and demands for cash. Both departments coordinated investigative efforts to determine if these robberies were connected.

Following a joint investigation between the Lake City Police Department and the Columbia County Sheriff's Office, three suspects were identified and arrested in connection with the series of robberies. The suspects were identified as Trever A. Strawder (DOB 01/14/1999), Ja'Kyris A. Martin (DOB 06/10/2005), and Ajahnnie L.

Ward (DOB 10/04/1998). All three were taken into custody without further incident.
