The September 6, 2023, quarterly meeting minutes were approved as presented, upon motion by Robert Milligan and second by Andy Miles; motion carried 4-0.

- a. Foster & Foster, Patrick Donlan, Plan Actuary
 - i. October 1, 2023, Actuarial Valuation Report
 - 1. Patrick Donlan reviewed the actuarial valuation report and explained the difference between market value and actuarial value.
 - 2. Patrick Donlan explained because the plan was overfunded, the cost to maintain was simply the normal cost of benefits plus the administrative expenses.

The Board approved the October 1, 2023, valuation report as presented, upon motion by Robert Milligan and second by Andy Miles; motion carried 4-0.

The Board voted the declaration of returns for the plan shall be 7.0% for the next year, the next several years, and the long-term thereafter net of investment related expenses, upon motion by Robert Milligan and second by Gregory Burnsed; motion carried 4-0.

- b. AndCo Consulting, Jorge Friguls, Investment Consultant
 - i. Quarterly report as of September 30, 2023
 - 1. Jorge Friguls reviewed the market environment over the last quarter and commented though the Feds continued to raise interest rates, inflation was still above the 2% target rate.

- 2. Jorge reviewed the allocations by asset class and did not have any recommendations for rebalancing.
- The Market Value of Assets as of September 30, 2023, was \$18,307,464. The total fund quarterly gross returns as of September 30, 2023, were -2.22%, compared to the benchmark of -2.82%. The trailing total fund gross returns for the 1, 3, 5, 7, and 10-year periods were 14.45%, 3.88%, 5.50%, 6.99%, and 6.75% respectively. Since inception (10/1/1998) the fund return was 6.30%, compared to the benchmark of 5.96%.

 - i. Michelle Rodriguez advised the Board she was working with the actuary and plan attorney to get this on the City Council agenda for first reading.
